- What's behind the 'No Money Available for Schools?' discussion? Our December branch meeting will feature two special speakers talking about the financial and political issues of school funding. What was budgeted and why is it complicated by the repayment of bonds? Why was there no money available until the Save Our Schools (SOS) and Red for Ed movements took the discussion to the public?
- Our speakers will be Harriet Young, PhD and Beth Lewis. Ms. Young is the Public Policy chair for Arizona AAUW. She is a retired Political Science professor at Northern Arizona University and holds a PhD in Political Science. Beth Lewis is the founder of Save Our Schools (SOS) and has taught 5th and 6th grades for eight years. Save Our Schools is a group of grassroots, nonpartisan, parents, teachers and business leaders supporting efforts to keep public money from being diverted to a universal school voucher program. Ms Lewis was awarded

the Rodel Exemplary teacher Award and holds a BA degree from University of Notre Dame, and MA in Education from Arizona State University.

Doors open at 10:30 for guests to enjoy a raffle and Silent Auction sale and the opportunity to meet and greet this year's scholarship awardees. Author Jan Cleere will be available to autograph her book <u>Levis</u> and Lace - Arizona Women Who Made History. The book is included in the \$40 cost of the luncheon.

Jan writes extensively about the desert southwest, particularly about people who first settled the territory. Her freelance work has appeared in *Arizona Highways*, *Persimmons Hill* magazine, *Phoenix Women* and the *Tucson Quarterly*.

In 2001, she received recognition from Arizona Highways for <u>Hostess of the West</u>, the life of Elizabeth Hudson Smith, a black entrepreneur in Wickenburg in the early 1900s. Jan belongs to several professional writers' groups. She is a presenter for the Arizona Humanities Council, giving hour-long presentations to groups across the state. She and her husband reside in Oro Valley.

The purpose of this event is to raise money for scholarships for East Valley women attending college/university in Arizona. The awardees include recent high school graduates as well as women returning to higher education after a break to work or raise families.
