Women in History: Alice Paul

For this year's Women in History reports, I am choosing women featured in children's books because I suddenly noticed that many of my friends are grandparents and the younger ones have small children. Maybe if you buy these books for them as children, they will grow up better educated about the rich yet often untold history of women and recruit future members into AAUW. The photo is of the children's book I found on Amazon. -- Mary deChesnay

Alice Paul, an early suffragette who authored the Equal Rights Amendment, was born January 11, 1885 in New Jersey into a Quaker family. Her father was a successful bank president and gentleman farmer. Alice's early life was privileged, but her Quaker parents believed in gender equality and respect for work and nature. They did not emphasize material possessions, but rather service to others. Farm hands did the hard work, but Alice and her siblings had chores and learned responsibility early on. As a child, she started attending suffrage meetings with her mother. An excellent student, Alice obtained a biology degree from Swarthmore College, a Quaker school founded by her grandfather, who believed in equal education for men and women. She and friends organized a parade for women's rights in Washington coinciding with President Woodrow Wilson's inauguration, and she obtained an audience with him to advocate for women's right to vote. Unlike her fellow suffragettes, Alice saw no reason to ease the pressure on Wilson as WWI was declared, and her group suffered imprisonment and torture as a result. They were force fed when they went on a hunger strike. Public outcries over the torture led to Wilson's reversal and support of the 19th Amendment in 1919. In 1923, believing that the fight was long from over, Alice authored the Lucretia Mott Amendment. Renamed the Equal Rights Amendment, it was passed by Congress in 1972, but has yet to be ratified by every state, including Arizona. In January of this year, Virginia became the 38th state to ratify the ERA, but there are still hurdles before it can be enacted into law. Paul died July 9, 1977 in NJ near her birthplace. The Scholarship Committee and Mentors hosted the second annual "Scholar - Mentor Coffee" on Saturday, October 17, 2020. This year we met on Zoom because of Covid 19. Scholars shared background information, where they're attending college and their major. Mentors also shared about their college backgrounds and careers. Last year the scholars did not know each other until we brought them together for the "Coffee". This year we have two scholars that are new to the program. All of them were so pleased to meet each other and discover that sharing has helped them to explore educational opportunities and even solutions for childcare or housing opportunities. They are all determined to complete their education no matter how many hurdles there are to cross. They are incredible young women!

My time as the Scholarship Committee Chair will end July 1, 2021. Working with the twelve scholarship recipients and their mentors is one of the most rewarding volunteer positions I have ever held. The twelve are an admirable group of young women from many different backgrounds. All of them have a financial need. Without our scholarship assistance, they would have a difficult time attending a two or four-year college and create a better life for themselves and their families. Our mentoring program offers friendship and encouragement to stay in college when the challenge of succeeding and completing the semester might be overwhelming. I feel that between myself, Joy Klein at Arizona Community Foundation and our mentors, we have made a real difference in the lives of our scholars. - B. Prepare the Agenda for the above Meetings.
- C. Provide leadership to the Scholarship Committee, Mentors and Scholarship Recipients.
- D. Act as a liaison between the Scholarship Committee and the AAUW of East Mesa Branch Officers.
- E. Communicate with Joy Klein, Scholarship Administrator at Arizona Community Foundation.
- F. Communicate with the Scholarship Committee, Mentors and Scholars.
- G. Plan Mentors' Meetings with the Chair-elect.
 - 1. Early October Meeting for training and sharing of Ideas.
 - 2. Spring Meeting in March to discuss successes and issues encountered during the year.
- H. The Chair, Chair-elect and the Scholarship Committee will recruit from the AAUW of East Mesa Branch members to become Mentors for the Scholarship Program.
- 1. The Chair position will be held for two years beginning July 1 (every other year).
- J. At the end of the two-year term, the Chair will serve on the Scholarship Committee as the Past Chair for one year or longer if requested by the new Chair.
- K. The position of Scholarship Committee Chair need NOT be filled by someone that is also a Mentor to one of the Scholarship Recipients. The Chair does not need to take on the responsibility of being a Mentor unless that is her choice.

General Meeting Minutes November 4, 2020

Call to Order: Called to order at 1:35 p.m. by Sandra Lackore

Quorum established - 32 members in attendance via Zoom.

Introduction of Board Members - Sandra introduced each Board member, and they gave a brief background.

Secretary's Report - Minutes from March, 2020 meeting - Beverly Byrd summarized the meeting minutes. Motion by Mary deChesnay, seconded by Betsy Flaten to approve. Motion carried.

Treasurer's report: Sandra Williamson highlighted the financial report. Ending balance as of 10/31/2020 - \$19,166.90. She explained that the checking account for the scholarship luncheon has been closed out and moved to the general fund.

Update from Board Meetings - Sandra Lackore updated the membership on the \$500 State Grant. The Board voted to augment the \$500 State grant and give \$15,500 to the Mesa Public School Foundation to be used for the following areas: \$5,000 for eye exams/glasses

8,500 for technology

2,000 for clothes and shoes

\$15,500

► In addition to provide a \$1,000 grant to AAUW National for emerging needs. The

\$16,500 to cover these grants was requested and has been received from the Larney

Family Trust Reserve. Sandra also discussed the decision to keep \$50,000 in the

reserve fund in case of a drop in the financial markets, so scholarships can still be

funded.

Update from Scholarship Committee - Judy Taucher-Lewis reported that on October 17, 2020 the Scholarship mentors and recipients had a virtual meeting. She reported 16 people were in attendance, and that the meeting worked very well. Judy discussed the duties of Scholarship Chair, and stated that the end of her term will be July 1, 2021. She stated the Chair position has been very rewarding for her. She discussed the impact the Larney Trust has had on the number of scholarships given from 3 or 4 to 12. Many thanks to Judy for all her hard work, and for developing a procedures manual for the position. If anyone is interested in volunteering, contact Judy.

Discussion regarding scholarships at the technical college level. Discussion regarding the Scholarship Luncheon and the importance of publicizing the scholarships to the community.

Women in History - Mary deChesnay gave a presentation on Alice Paul. Mary noted that she will try to highlight women that have a children's book written about them. Alice Paul was an early suffragette who grew up in a Quaker family in a climate of gender equality. She militantly fought for women's rights in the US and in England. The children's book that follows her life is *"Alice and the President."* Information on her life can be found at the Alice Paul Institute website. Thank you, Mary, for the presentation!

Small Group Sharing - thanks to Betsy Flaten for organizing the small group Zoom meetings. Each small group reported, and the general consensus was that the small group meetings are an excellent way for members to get acquainted. The goal of the groups is to make connections.
